Minutes of Third Month were approved as submitted.

The Treasurer reported that our income year to date is slightly behind our budgeted amount and our expenses are below budget.

The Treasurer presented the 2014-2015 budget for the first reading. Most expense categories either stayed the same or had modest increases. The largest expense increase is for the cost of building a new meeting space. The monthly mortgage for the current meetinghouse and the new meeting space is projected to be about \$1700 per month (about \$600 more than our current mortgage payment).

Karen Putney, of the ad-hoc fundraising committee, presented a draft letter (Appendix A) to be sent out to the meeting requesting individuals to discern their ability to increase their contribution to the meeting in light of the new mortgage obligations. Meeting approves the letter.

Worship Sharing sessions are being held weekly on Tuesdays at 7 p.m. at the Meetinghouse. We continue our Food Pantry, an ongoing collection of non-perishable items for use as needs present. The committee also suggested that we read the queries and advices at the end of Joys and Concerns instead of at the beginning of meeting.

Peace and Social Concerns – Karen Putney reported that the committee is bringing forward a draft letter from our meeting to Rep. Kathy Castor requesting her support to repeal HR 2324, a blanket authorization for military deployment without congressional approval. Meeting approves the letter. We would also like to share the letter with Friends at yearly meeting in hopes other meetings will be led to such action also. We also need someone(s) to sit at a Quaker table at the March Against Monsanto. The committee is also working with SEYM youth in an action at PNC Bank's shareholder meeting on April 22 to protest PNC Bank's support of mountain top mining. Nancy Triscritti reported that the meeting has collected more than 500 books for school children who do not have access to books at home.

Dear Friends,

We have found unity on our need and determination to move forward with the building of a new worship space. The Property Committee has worked with an architect and is now consulting a builder seeking the most cost effective way to make this happen. Property has also submitted a request to refinance our current loan with the Friends Meetinghouse Fund. This loan had been paid down substantially and we have heard from FMF that our request will be granted but we need to be clear about exactly how much money we need to borrow. The ad-hoc fundraising committee has met to consider other possible sources of funding. We are clear that our monthly financial obligation, which includes our mortgage as well as operating expenses, will be going up.

In order to move forward, we need to ask ourselves how we each may be led to support our community in meeting our financial obligations. We understand that at any given time our individual circumstances vary greatly and support may come in other forms when financial support is not possible. We do not wish to pressure one another or cause embarrassment around that often sensitive issue of giving. However, it would greatly help us move forward in a responsible way if we each could take time for discernment on the following queries and return/mail them to the address below. Even if financial support is not possible at this time, it would be good to hear back. You may sign the form or not. We share this to help each of us think through what we will do to financially support this project so that we may move forward in a responsible and successful manner.
